CAMPAIGN UPDATE

Reason to Be Proud Campaign Project Given Green **Light—Construction on New Chapter House Scheduled for** January 2008

More Funds Needed to Ensure Complete and Successful Renovation, Reach Deep and Support the Phi Sig Active Chapter!

The Reason to be Proud Campaign is pleased to announce that the board of directors of the Phi Sigma Kappa Association recently voted to proceed with the house renovation project. Even though we have a long way to go, I want to thank all the supporters of the campaign. We would not be at this stage without your support.

We now have just slightly less than \$950,000 in donations and pledges for the campaign, an increase of over \$200,000 since the summer. Fantastic, way to go!!!

While we fell slightly short of our \$1 million goal, the board concluded that we came very close and have a viable enough project to proceed. The board also approved seeking a \$1.2 million loan for the project. Steve Courter '77 and the campaign finance folks are now preparing the loan application. Dave Hyland '80 and the building committee are working with our architect on the bidding documents for the project. We intend to close the house and start construction in early January 2008, and be ready to re-open for the fall 2008 semester.

We are not out of the woods yet, though. Total project costs are likely to exceed \$1.5 million, so we have over a half-million-dollar gap between total costs (expected) and total pledges received so far. This gap may grow once we see the responses to the bidding documents that we will distribute soon. Costs can further increase once work commences and the walls and ceilings of our 80-year-old house are torn down and replaced.

Therefore, we need additional financial support to make this project successful. The more funds we raise, the more things we can include in the project. We really do not want to pare back the proposed renovation/redesign project, because most of it really is designed to comply with life/safety requirements and to enhance the living experience at Kappa Chapter. Soon we will place drawings of the proposed redesign of the house and details of the proposed project on our website (www.phisigpsu.com).

If you have not made a pledge yet, we ask you: did you benefit from your living in the house and being a member of Kappa Chapter? If so, will you help support our efforts to preserve Kappa Chapter for future generations? When we started this project, many doubted we could even raise more than \$750,000. We want to build on this success.

Do you have sons who will be attending college in the future? If they plan to attend Penn State and will consider a fraternity, Kappa

ALUMNI PROFILE

Kevin O'Leary '71, Alaskan Fisherman and Businessman Extraordinaire, Recently Honored by the Penn State Alumni Association as an Alumni Fellow for His Significant Contributions to World

Kevin Combines Trip Back to Happy Valley with a Surprise Visit to Brothers' Tailgate

Q. Why did you join the fraternity?

A. Penn State was a big school, so during my freshman year I began looking for a small social milieu of which I could be part. I knew some people that I liked from Phi Sigma Kappa and that's why I chose to join the fraternity.

Q. What was your favorite memory of the fraternity?

A. My favorite memory comes from sitting down to dinner, all of us together, every night. It was a formal dinner where we were civilized, and observed good manners—families did that back then.

Q. What kind of influence has this had on your life?

A. Nothing profound, but it has provided me with friendships and relationships that I've maintained over the years.

Q. With whom do you stay in contact?

A. Rich Weaver '72, Paul Church '71
and Bill Warfel '71 from my pledge class;
and Tom Saltarelli '69, Steve Brose '69
and Tom Renehan '69. The people in my
pledge class see each other socially two or
three times a year, but I live so far away that
I cannot participate. However, I did just
visit with them recently at the Penn State vs.
Wisconsin game on October 13th. I showed
up unannounced at their tailgate when I was
back in State College to receive the 2007 Penn
State Alumni Fellows Award.

Q. Tell us about your family.

A. I married my college sweetheart, Susan Opal O'Leary, 35 years ago. She became a teacher and retired from the Kodiak Borough School District, Alaska, in 1998. We have two sons: Timothy, 29, and Brian, 21. Timothy

has been involved in commercial fishing in Alaska, and now he is helping me develop 143 acres near Kodiak. Brain is a student at the Texas Christian University in Fort Worth. He is a business/marketing major.

Q. What other activities or organizations were you involved with during your college days?

A. I played lacrosse my first two years at Penn State, then got too busy academically and had to stop.

Q. Did you live at the house? If so, who were your roommates?

A. I lived at the house my sophomore and junior years, and then in an apartment by myself my senior year. Tom Saltarelli was my sophomore year roommate, and I had a private room my junior year.

Q. What do you do for a living? Tell us about your career.

A. I spent a couple years bartending at resorts across the US after graduation. While bartending in Aspen, a friend who was living in Alaska called and told me I had to come north to see it for myself. I began bartending on Kodiak Island, but the second time a gun went off in the bar where I worked, I decided I'd rather die doing something else, not be shot bartending. That's when I started fishing—that's really the only thing to do there. I fell in love with fishing as a lifestyle.

I fished on dangerous, derelict boats at first as this was a small community where I was an outsider and I had to prove myself. Then I began working on a good boat and saving money. I was in a place where the fishing industry was starting to grow and become a substantial economic opportunity. We were just beginning to scratch the surface of its potential.

It wasn't long before I became a captain. A year later, an owner/operator offered to partner with me to buy a boat and we began our own business. After three years, I bought him out and added another boat five years later.

I eventually got another partner and began a factory boat fishing business, all the while still going to sea myself. In 1995, I had to get off the sea to spend more time managing the business. I am still active in the management of Sunrunner Alaska Corp. and Alaskan Leader Fisheries, though my wife and I live in Arizona during the winter now. We still have three factory boats, and I am the sole owner of a halibut, sole, cod boat that fishes off Kodiak.

My focus now is to develop a 143-acre tract of wilderness I own near Kodiak. My son and I will be opening a fishing and hunting lodge there within a year or two.

Q. What affiliations do you currently have and/or public service do you participate in?

A. I spent six years on the North Pacific Fishery Management Council and have stepped away from that. I support certain charities in the communities.

Q. What hobbies do you enjoy?

A. Most of time during the summer I'm working on the property development: there is a lot of work to do building the infrastructure for the lodge. While I'm out there, I hunt and fish. In the winter, I live in Fountain Hills, AZ, where I play golf and travel.

Q. What are your goals for the next few vears?

A. To get the lodge up and running by end of next summer, and complete my new home in Arizona.

Q. Why do you think it is important to support the chapter as an alumnus?

I have supported the chapter over the years because I feel I personally benefited from my experience in the fraternity, and I want to see the tradition that is Phi Sig continue.
